About the Gulf of Mexico Fishery Management Council

The Gulf of Mexico Fishery Management Council is one of eight regional Fishery Management Councils established by the Fishery Conservation and Management Act of 1976. The Council prepares fishery management plans, which are designed to manage fishery resources within the federal waters of the Gulf of Mexico.

The Council must balance competing interests while making decisions for the public good. To do so, the Council is supported by Council staff and advised by various panels and scientific committees, the states, academia, NOAA Fisheries Service, and the public.

Council Members

Council members are trustees for the fisheries, which are common property of all U.S. Citizens.

The 17 voting members include: Eleven private citizens who are knowledgeable about conservation and management, or the commercial or recreational harvest of the Gulf resource; the directors (or their designees) of the state fish and wildlife departments from Texas, Louisiana, Mississippi, Alabama, and Florida; and the Regional Administrator of NOAA Fisheries Service Southeast Regional Office, or a designee.

The four non-voting members include: The Gulf States Marine Fisheries Commission, which coordinates data and research for the Gulf States; the U.S. Fish and Wildlife Service, which serves an advisory role; the U.S. Department of State, which is concerned about management decisions that have international implications; and the U.S. Coast Guard, which is concerned about enforcement and safety issues.

Council Staff

Council staff support the Council by providing information for management decisions; providing information to the public about Council activities; helping the public participate in the process; coordinating the process and meetings; assisting advisory groups; and creating fishery management documents.

Advisory Bodies

To ensure a well-rounded understanding of each component of fishery management in the Gulf, the Council draws upon the expertise of knowledgeable people from other state and federal agencies, universities, and the public. Advisory bodies and science committees review fishery management issues and provide recommendations to the Council.
